- All tents must be properly weighted for safety. Tent stakes are not permitted unless approved by event organizers.
- Booth spaces are approximately 10' x 10'. Vendors must remain within their assigned space unless otherwise approved.
- Vendors are responsible for collecting and remitting all applicable Minnesota sales tax.
- The Lake City Chamber of Commerce reserves the right to determine vendor acceptance and product eligibility to maintain the integrity of the Harvest Market.
- Vendors agree to remain set up for the duration of the event (10:00 AM–5:00 PM) and may not begin tear-down before 5:00 PM unless approved by event staff.
- The Lake City Chamber of Commerce is not responsible for lost, stolen, or damaged merchandise, equipment, or personal property.
- Submission of an application does not guarantee acceptance into the Harvest Market.
